demonstrate integrity through innovative thinking and measures!**

The Ministry of Justice Ceremony for Awarding 2024 Model Ethics Officers and Joint Oath-Taking of Newly Appointed High-Level Government Ethics Officers was held at the grand hall of the Ministry of Justice on July 30<sup>th</sup> at 10 AM, hosted by Minister Cheng, Ming-Chien.

11 newly appointed high-level government ethics officers were congratulated and encouraged by the Minister to have innovative thinking and strong will to shape their organizations' visions, as well as lead their team with enthusiasm, courage, and a sense of responsibility, giving a new face to the culture of integrity. The Minister stated that in recent years, many female supervisors have performed outstandingly in anti-corruption work and deserve to be encouraged and promoted; for the first time, two Rank 12 female commissioners have taken up their posts, which shows that the power of women is gradually emerging. At the same time, the Minister congratulated the 12 recipients of the Model Ethics Officers Award this year, including entry and mid-level supervisors and non-supervisors from different regions and professional fields across the country. This demonstrates the cross-domain and diverse professional qualities of anti-corruption personnel, showing their serious commitment and dedication to their work. The Minister especially said that family members of the recipients were invited to the awarding ceremony to share their glory, and it

felt warm and deeply gratifying when the grand hall of the ministry was filled with the laughter of children, who are the future of our country.

The Minister stated that videos of the recipients' deeds showcase our government ethics officers' sense of mission and the inheritance of anti-corruption work, while the selfless support and dedication of their families, friends and teams are the elements that enable them to devote themselves to their work. Our effort in anti-corruption is well received by all walks of life, demonstrating Taiwan's tenacity in building a clean government. The Minister then put forward four expectations: 1. Be self-disciplined before you command others, and set an example in everything. 2. Put prevention first to reduce integrity risks. 3. Public-private collaboration and cross-domain cooperation to bring together the strengths. 4. Innovative thinking and efficient problem-solving.

The Minister said that anti-corruption work must not be done behind closed doors, and stressed the importance of working together with others while encouraging government ethics officers to strive to assist the head and colleagues in their respective agencies to build strong partnerships. Outside the agency, they should actively cooperate with relevant units across domains. The Minister mentioned that when he served as the Director-General of the Agency Against Corruption, he constantly thought about how to promote anti-corruption work in more effective ways, and expected the ethics units to use their existing organizational networks and professional capabilities to help promote anti-fraud work, prevent crimes from the source, so that the public can relate to such achievements. He also acknowledged the efforts of the entire anti-corruption team and the continuous promotion of the Government Procurement Integrity Platform and the Integrity Platform for Enterprise Services, which have gathered the strength of the

public and private sectors. In the future, we should continue to upgrade the operation of such platforms, not only the elevation of “quantity” but also the improvement of “quality”. In addition, by organizing the “Integrity Awards”, public sectors across the country are encouraged to participate to understand the importance of administrative transparency and clean governance.

The Minister is very grateful to all ethics personnel, their relatives, and friends for their selfless dedication and support, which are valuable assistance in promoting anti-corruption work. The Ministry of Justice and the Agency Against Corruption will work resolutely to ensure the stable development of construction projects in Taiwan.
